	Treasurer absent. Secretary spoke to the Treasurer's report, focussing on the reported \$40k loss. Advised the following key points as to why this occurred: Shortfall in grant funding towards committed expenditure (driven by shortfalls in providers funds due to lockdowns etc), key call outs include: Pin the play - \$13k Physio - \$7k Admin fees - \$8k Bad debts - \$4.5kish Legal fees re case during year \$3.5k Secretary advised a number of these items will be addressed in 2022 by ensuring commitments are not finalised until funding has been approved or workable alternatives found. In addition, there is an expectation of some additional support from VUW & Jarden sponsorship will have a broader club focus than last season. R Drummond spoke to the impending 'Sliver Lake deal' NZRU is investigating. All clubs need to ensure they actively engage with WRFU as to planning for the proposed down trickle of funding to all levels of the game. In addition, the club's financial difficulties could be alleviated through active engagement with older supporters. M Wills (WRFU Delegate) responded that planning was underway with WRFU looking at a Club Development type manager to bolster support for clubs. Ted Thomas asked what has been done to assess how to rectify the loss for 2021/22 Financial Year & what steps are being taken to secure the club's financial future through development of a capital base. 8.01	Premier Home Matches 2022	
	Secretary advised that WCC and WRFU have been concerned about Nairnville Park. The club to ensure they treat the venue with respect and for team mangers to ensure all rubbish is picked up from both changing rooms, with photo to be taken before leaving. WRFU to issue guidelines to all clubs on personal and team responsibility for clubs to comply with. Covid protocols at Nairnville means anyone entering to use changing rooms or toilets must produce vaccine passes, WCC staff will on the door. However, of greater concern was advice of abuse of WCC staff at the centre, this to be investigated further and club members to be advised this is completely unacceptable & that any instances of abuse of Recreation Centre staff to be immediately reported. Nairnville Park is most likely to be the main venue for OBU home matches in 2022 as Rugby League Park issues are still being sorted. M Wills added that discussions are leading to possible involvement with Rugby League Park for 2023. However, WRFU to be asked for an opportunity to play marquee 'Old Timers Day' & 'Jarden Welcome' match(es) at Rugby League Park due to Wellington College not being available for Premier Rugby this season. This is due to tighter covid restrictions impacting upon the school. In addition, due to no test match cricket scheduled for the Basin Reserve in 2022, a request be made for OBU's return to this as their home	
	ground for Premier Rugby and seeking WRFU support in this matter.

Outcomes is they want to increase Saturday use of non OBU events, post 7pm & all club members to download the App and use it. They have requested removal of much of OBU memorabilia from the walls to make it more attractive and usable for other events. They have committed to continuing meals for Premier team and opposition. Revenue targets have been set for cash-back opportunity. Key will be to get club members to use the App. Other options are being explored, but no opportunities are presenting themselves for a venue change in 2022.
